Affiliation of GHI with the African Journal of Food, Agriculture, Nutrition and Development (AJFAND)

As many of the readers will remember, it has been the wish of many members as well as the Board to have a "home" journal for GHI related articles. The options have been investigated and a number of you have participated in this investigation by submitting articles for a trial "special" issue of the journal "Quality Assurance and Safety of Crops & Foods", published by Wageningen Academic Publishers. Although that special issue was successful and can be downloaded from that journal's website ([click here](#)), developments at the publisher made the journal inappropriate for GHI. After thorough investigation of a number of options, the Board reached the conclusion that the African Journal of Food, Agriculture, Nutrition and Development (AJFAND) would best meet the needs of GHI and its members. Consultations between AJFAND and GHI resulted in an agreement to make AJFAND the GHI-affiliated journal. The agreement has been signed in March of this year and this issue is the first one that incorporates the GHI newsletter "GHI Matters" that you are reading now.

About AJFAND

The African Journal of Food, Agriculture, Nutrition and Development (AJFAND) is a highly cited, prestigious and thoroughly peer reviewed journal with a global reputation, published in Kenya by the Africa Scholarly Science Communications Trust (ASSCAT). It is indexed in major scientific literature databases, including:

AJFAND is an open access journal, meaning that everyone in the world can read the articles without any costs. It also means that a publication fee is needed, to be able to maintain a secretariat and the costs associated with production, in particular online hosting and communication. AJFAND, however, charges article processing fees only once an article has been accepted for publication having passed the review process. This is so that editorial decisions are not influenced by the ability (or inability) to pay. The fee is \$750 per article,

which is significantly less than most other journals. AJFAND extends rebates in circumstances of hardship. Researchers are encouraged to incorporate publication costs in their budgets.

Apart from publishing GHI Matters in AJFAND, GHI will also publish official GHI documents in the journal, such as the Global Scientific Consensus documents. The membership of GHI is encouraged to submit articles related to the goals of GHI, but also any other article that falls within the scope of AJFAND as a regular article. GHI working groups are encouraged to publish articles based on the activities of their groups in the journal.

A presentation about Covid-19 and food

Prof. Franco Pedreschi Placencia, Director del Departamento de Ingeniería Química y Bioprocesos of the Pontificia Universidad Católica de Chile and a GHI Chilean Ambassador, in cooperation with the Chilean Food Safety Authority developed a video, "Agencia Chilena para la Inocuidad Alimentaria" (ACHIPIA), del Ministerio de Agricultura de Chile, a video about food safety in relation to SARS-CoV-2. That presentation is in Spanish and focuses on Chile. However, it is a clear and well-done presentation on the topic that could help everyone in the world who has a role in the food chain.

Therefore, with permission of the producers of the original video, a team from the Food Microbiology Workgroup, consisting of Noor Zafira Noor Hasnan, Mohd Zuhair Mohd Nor, Nur Hamizah Abdul Ghani (all from Malaysia) and Rozita Vaskoska (from Australia), adapted the video so that it is applicable globally. And at their request one of our native English members, Debra Smith (from the UK), has reviewed the English text. The end-result is a video that is useful and which can also be translated into other languages without requiring any further permissions. The video can be downloaded from the GHI Library, under the submenu "GHI Member Presentations". Several ambassadors are making a translation of the presentation into their national language. Food Safety Profession proposal - A plan for globally safer food

There are few formal requirements around the world for those in the food chain responsible for the design and management of food safety, while frequently food safety incidents take place, harming consumers. The working group (WG) for Ethics in Food Safety Practices, supported by the GHI Board feels that food safety professional (FSPro) should be a globally recognised regulated profession. To that end the WG developed a proposal describing the responsibilities, the education requirements and the establishment of professional bodies and registers for this purpose. 
