### **Books**

Many members have contributed to GHI books and sometimes finalizing a book takes more time than expected and we receive message about when the book, with their chapter in it, will be published. Reasons for the delay are many, some of them totally unexpected, such as authors who died, before completing their chapter. In other cases, the pandemic caused by the SARS-Cov-2 virus caused significant delays. Some authors suddenly were almost literally sucked into the pandemic because they had to join a project team working on vaccines. Many others had to switch to online teaching and although some had done so or were doing so for some time, for others it was the first time.

#### Food safety management: A practical guide for the food industry, 2nd edition

We are approaching the end and soon Elsevier may start the production process. Authors will find out when they receive the proofs from Elsevier for eventual corrections and then approval. The planning of Elsevier is publication by the end of this year. However, it may be a little later.

This book will present a series of real food safety incidents, experienced by food safety professionals. The stories may help with teaching food safety, showing what unexpected incidents may happen and why an open mind is always important, to see failures that may not be explicitly in any book. The book may serve as a teaching tool and complement other existing books such as the Food safety management book discussed above, or the Handbook of hygiene control in the food industry (Elsevier 2016).


### Nutrition and health aspects of traditional and ethnic food of Eastern Europe
