
For those living and working in the European Union

The Pseudocereals Book



The 1st Edition of the Pseudocereals Book edited by Viduranga Waisundar who is a Co-Chair of the GHI Nutrition Working Group has been published and is accessible. Pseudocereals are being hailed as a means of combating food and nutrition insecurity around the world. They are plants that produce fruits or seeds that are used and consumed as grains and thus they have the potential to withstand harsh weather conditions and other issues faced by most crops currently grown. Ultra-processed Foods Classification

Recently, Hervé This (herve.this@agroparistech.fr) published a note about an article in the European Journal of Clinical Nutrition with the title "Ultra-Processed Foods: How Functional is the NOVA System?" The article analyzes the robustness of the "NOVA" food classification system, where four categories are proposed, according to the degree of transformation. Hervé
