# **Publications by GHI Members**

GHI Ambassador for Iran, Dr. Hamid Ezzatpanah *et al.*, have published a comprehensive review entitled 'Risks and new challenges in the food chain: Viral contamination and decontamination from a global perspective, guidelines, and cleaning'. This review paper analyses and makes comparisons of the efficacies of cleaning practices currently used in the food industry for removal of pathogenic viruses from air, non-food, and food contact surfaces, as well as from food surfaces.
